Item	Discussion
Matters Arising	The Mayor noted that he had amended the minutes of Dec 21 <sup>st</sup> 2015, relating to the management of the Edge team on supply ship day so as to clearly reflect that the task remains with the Operations Department not within the role of Deputy Mayor.
Record of Approval of Public Meeting Notes Dec 21 <sup>st</sup> 2015	Motion: Cr Griffiths/ Cr B Christian “That the Public Meeting Notes of Dec 21 <sup>st</sup> 2015, as amended, be approved and recorded as true and correct.” All in favour Carried.
Bounty Festival	Cr Darralyn Griffiths conveyed that the next Bounty Festival is scheduled for Oct 7 <sup>th</sup> - 9 <sup>th</sup> 2016. She reported the organisers are interested in having a Pitcairn Delegation attend. It was noted that travel will again be the issue. Cr B Christian stated that the owner of the vessel has previously conveyed they are open to being available again if needed and that she has contacts available if required.  It was agreed that Cr Griffiths will liaise with the Festival Organisers as to the possibility of a delegation attending the festival and report back to Council.
Council Workshop 2016	The Mayor reported that he and the Administrator will facilitate a workshop to discuss Council structure and the role/responsibilities of the Administrator. A date for the workshop will be confirmed shortly.
GPI Structure Update	The Mayor reported that he has provided the Deputy Governor with a revised visual of the current GPI Structure. The new document was tabled for Council’s information and is available from the Mayor.
Revised Settlement Application Form	The revised Settlement Application Form, which has been reviewed by Deputy Governor Lynch, was tabled. There were only a few comments and amendments all of which were agreed upon. ACTION: The form will be finalised, circulated and forwarded to the Web Manager for new Immigration website.

Draft Home Detention Ordinance.	The Administrator advised that the legal experts have drafted an Ordinance for home detention. The draft ordinance and its explanation will be coming to Council shortly.
Presentation from Community Police Officer Sergeant Terry Moore	The Community Police officer presented a plaque to Council, from Sargent John Singer and his wife Linda. On their behalf he thanked Council and the Community for the time John and Linda spent on island. The gift was well received by Council on behalf of the people of Pitcairn.

Cr Michele Christian removed herself from the Council workshop to avoid any conflict of interest. Given the Mayor's relationship, with Cr Michele Christian he too offered to step away from the workshop. Council declined this offer and Cr Jaques' letter of complaint was given consideration. It was agreed Council's draft response will be circulated for final approval shortly.
